

Pet Adoption with Spay or Neuter Contract

This contract is for the adoption of a cavalier from Cache Valley Cavaliers for the specific purpose of being a pet with no breeding rights conferred, and thus requires the pet to be spayed or neutered by 6 months of age. Allowing your adopted cavalier to sire or deliver a litter (intentionally or not) changes the contract to a Breeding Prospect Contract, and additional funds are immediately due to Cache Valley Cavaliers which are double the price of a Pet Contract. Should this clause be triggered, the owner will be due all rights and privileges that come with a breeding contract.

According to Preventive Vet and the AKC, the puppy shot series usually starts between 6–8 weeks of age, with new vaccines and boosters given every 3–4 weeks until the puppy is 16–17 weeks old (some puppies may need an additional booster at the roughly 20 week old mark — this is especially true with the "black & tan" breeds). A suggested vaccination schedule is listed below as well as vaccines given through the date of adoption.

6 – 8 weeks	Distemper, parvovirus	Bordetella
10 – 12 weeks	DHPP (vaccines for distemper, adenovirus [hepatitis], parainfluenza, and parvovirus)	Influenza, Leptospirosis, Bordetella, Lyme disease per lifestyle as recommended by veterinarian
16 — 18 weeks	DHPP, rabies	Influenza, Lyme disease, Leptospirosis, Bordetella per lifestyle

Every 1 - 2 years	DHPP	Influenza, Coronavirus, Leptospirosis, Bordetella, Lyme disease per lifestyle

Pet Adoption with Spay or Neuter Contract

Terms of this Agreement

Consideration is for the Cavalier King Charles Spaniel (CKCS) identified in this contract, and is considered the sale of personal property.

This contract is for the adoption of a cavalier from Cache Valley Cavaliers for the specific purpose of being a pet with no breeding rights conferred, and thus requires the pet to be spayed or neutered by 6 months of age. Allowing your adopted cavalier to sire or deliver a litter (intentionally or not) changes the contract to a Breeding Prospect Contract, and additional funds are immediately due to Cache Valley Cavaliers which are double the price of a Pet Contract. Should this clause be triggered, the owner will be due all rights and privileges that come with a breeding contract. Proof of spay and neuter needs to be received by Cache Valley Cavaliers by 7 months of age. If no proof is provided, Cache Valley Cavaliers has the right to revert the contact to a Breeding Prospect Contract and pursue payment and damages.

A deposit of \$1,000 USD is due at signing of this contract to put this contact in force. Said deposit is non-refundable, but can be applied to another consideration should conditions warrant and be approved by Cache Valley Cavaliers.

An adoption fee of \$ will be collected from the Adopter at or before the time the Adopter takes physical control of the consideration, minus any deposits for said adoption.

Acceptable forms of payment are cash, Venmo, credit card, PayPal, wire transfer, or other method to be determined between the Adopter and Cache Valley Cavaliers.

The Adopter agrees to keep and take care of their new CKCS in a safe and humane manner in accordance with the guidelines set forth by the AKC, the CKCSC, and the ACKCSC.

The Adopter understands that pets require appropriate food, water, shelter and medical care for the duration of their life and shall ensure they are properly taken care of and will nourish them to the best of their allowed capacity.

The Adopter understands their responsibility to become familiar with and comply to the local and state laws relating to licensing and animal welfare, and shall abide by them.

In case of incapacity to continue to care for the consideration, it shall be the responsibility of the Adopter to inform the previous owner of such incapacity by which the former owner shall have the right to exercise their retained Right of First Refusal in the opportunity to reclaim the consideration.

The parties understand that there are no guarantees or warranties with regard to the behavior or temperament of the consideration.

Any damages or injuries caused by the actions of the consideration once in the control of the Adopter shall be borne by the Adopter.

Breeder states that the consideration is healthy at the time of sale. For purposes of this agreement once the consideration leaves the premises of Cache Valley Cavaliers it is under the Adopter's control. A one-year health guarantee tied to genetically inherited diseases is provided with each adoption from Cache Valley Cavaliers. We strive to produce quality pups for our clients, but recognize that there are limits to what can be known at the time of adoption with respects to genetically inherited health issues. Damages are limited to the return of adopted consideration for a replacement consideration of equal value from Cache Valley Cavaliers. No refunds or the covering of costs associated with any action including veterinary care, legal fees, or transportation are implied or offered.

It is highly recommended that the Adopter has their puppy checked by their personal veterinarian within 10 days of receiving their puppy. This is to establish a working relationship with your veterinarian, to develop a baseline of care for your new CKCS, and to put in force the Health Guarantee. Have the proceeding "veterinary examination report" completed by the attending veterinarian. This report must be returned to Cache Valley Cavaliers within 3 days of the examination. The report may be sent in electronic fashion.

The parties declare that they enter into this contract voluntarily, without any reservation, and have not been induced or coerced.

Should any of the provisions of this Agreement be held invalid, such invalidity shall apply only to the said invalid provision and the remaining provisions shall continue to remain valid and enforceable.

No modification or alteration to any part of this contract shall be considered as having been made unless executed in writing and duly signed by both parties.

This agreement is made and entered into in the State of Utah and shall be enforced and interpreted under the laws of the State of Utah.

I have read, understand, and agree to these terms and limitations. I consider this to be a legally binding document.
